


Physician Compensation Benchmarking:

Impact of 0% fee increases in 2020/2021 and 2021/22 – All Physicians

Executing the Benchmarking Methodology – Steps 1 to 4

- The results for each of the first four steps of the benchmarking methodology are depicted in the chart below
- MacKinnon figures are also shown and demonstrate the impact poor benchmarking decisions can have on establishing fact-based plans and expectations; using recent CIHI data and reasonable comparators reduces MacKinnon's 35% by more than half



Explanatory notes:

Ontario

Updates to rates for 2018/19 and 2019/20 in **Ontario** were applied as follows (arbitration award adjustments):

- **2018/19:** 1.25% + 0.75% = 2.0%
- 2019/20: 4.95% (3.95% + 1% ATB) applied to Fee-for-service clinicals payments; 3.65% (2.65% + 1% ATB) applied to non-Fee-for-service clinical payments

Saskatchewan

SMA and provincial government remain in negotiations. The average of the fee rates increase between 2011/12 and 2017/18 (1.13%) was used to estimate fees from 2018/19 to 2022/23

Note:

1) 2018/19 and 2019/20 updates for Ontario: Updated to reflect reversal of governments unilateral across the board discounts implemented after 2014
