

**ALBERTA MEDICAL ASSOCIATION AMENDING AGREEMENT TO THE  
STRATEGIC AGREEMENT**

**Made effective April 1, 2018**

**BETWEEN:**

**Her Majesty the Queen in right of Alberta,  
as represented by the Minister of Health  
("AH")**

**- and -**

**Alberta Medical Association  
(C.M.A. Alberta Division)  
("AMA")**

**- and -**

**Alberta Health Services  
("AHS")**

**RECITALS:**

- A. AHS, AMA and AH are parties to a Strategic Agreement in effect from November 1, 2016 to March 31, 2018 (the "**Agreement**");
- B. The parties wish to extend and amend certain provisions of the Agreement as set out in this amendment ("**Amending Agreement**").

The parties therefore agree as follows:

**1. Interpretation**

- (a) In this Amending Agreement and the recitals, unless something in the subject matter or context is inconsistent, all capitalized terms used without express definition have the same meanings ascribed to them in the Agreement.
- (b) The division of this Amending Agreement into Sections and the insertion of headings and the schedule are for convenience of reference only and do not effect the construction or interpretation of this Amending Agreement.
- (c) This Amending Agreement is governed by and construed in accordance with the laws of the Province of Alberta, excluding principles of conflicts of laws that may require the application of foreign laws. The parties attorn to the jurisdiction of the courts of the Province of Alberta.

**2. Amendments**

The Agreement is hereby amended as follows:

- (a) All references to "March 31, 2018" are hereby deleted and replaced with "March 31, 2020".

**3. Effective Date**

- (a) This Amending Agreement is effective as of the 1<sup>st</sup> day of April, 2018.
- (b) Notwithstanding the date this Amending Agreement is signed, it will be effective from April 1, 2018.

**4. Signing and Delivery**

This Amending Agreement is subject to approval by AH and ratification by the members of the AMA.

**5. Confirmation of Agreement**

- (a) The Agreement, except as expressly amended by this Amending Agreement, continues to be in full force and effect and the Agreement as amended by this Amending Agreement, is ratified and confirmed and continues in full force and effect as amended, with such amendments being effective as and from the specific dates set out in this Amending Agreement.
- (b) Other than as expressly provided for herein, this Amending Agreement does not serve to amend any terms or conditions of the Agreement, the terms and conditions of which shall remain in full force and effect otherwise unamended. This Amending Agreement is entered into as a supplementary document to the Agreement and is subject to the other terms and conditions of the Agreement and, in particular, all provisions and terms of general interpretation, construction and application, all of which are hereby incorporated by reference and deemed to be made a part hereof.

**6. Further Assurances**

The parties will from time to time do all such further acts and things and execute and deliver all such documents as are required in order to affect the full intent of, and fully perform and carry out the terms of, this Amending Agreement.

**7. Enurement**

This Amending Agreement enures to the benefit of, and is binding upon, the parties and their respective successors and permitted assigns.
